ALL HORSES MUST BE IN A STALL (1 horse per stall). Once all stalls are filled, then we will be allowing portable pens to be set up (limited to 12x12, with 1 horse per pen) in the dry camping area only. No portable pens allowed in the infield but you will be allowed to tie your horse to your trailer in the infield during the day. Horses will not be allowed to be tied to trailers overnight. **Horses are not permitted in the RV Park or 31 Electrical Camp.**

- There will be a \$25 late fee assessed for all reservations received or payment made after May 21, 2020.
- All stalls and camping spots will be assigned by NWSOA **ON A FIRST PAID BASIS. IF YOU WANT TO BE STALLED OR CAMPED NEAR OTHER MEMBERS OF YOUR CLUB, YOU WILL NEED TO SUBMIT YOUR RESERVATIONS TOGETHER. RESERVATIONS WILL NOT BE MADE UNTIL PAID IN FULL.**
